UPON THE APPLICATION of the Municipal Council of
the Corporation of the Township of Schreiber, and a public
hearing having been held on the 5th day of May, A. D., 1953,
notice of which was given by publication as directed by the
Board, at which no person appeared to oppose the application;
and upon consideration of the material filed,

THE BOARD ORDERS:

- (1) THAT the Corporation of the Township of Schreiber
has the legal existence and corporate status of a Township and
has had such existence and status from and after the 1st day of
January, A. D., 1901;
- (2) THAT the proper area of the Township of Schreiber is
that of the "Municipality of Schreiber" as shown on a map of
Township 84 on file in the Office of the Surveyor General of
Ontario;
- (3) THAT the boundaries of the said Township may be
described as follows:

THENCE East astronomically 3 miles more or less to the intersection with a line drawn North astronomically from the North-west angle of the Improvement District of Terrace Bay as established by Phillips & Benner, Ontario Land Surveyors, in the year 1949, and shown on Plan of Survey dated February 6th, 1950, of record in the Department of Lands and Forests, Ontario;

THENCE South astronomically along the said line 86 chains more or less to the North-west angle of the Improvement District of Terrace Bay mentioned aforesaid;

THENCE SOUTH astronomically along the West boundary of the Improvement District of Terrace Bay as surveyed by Phillips & Benner, Ontario Land Surveyors, and shown on Plan of Survey dated February 6th, 1950, and of record in the Department of Lands and Forests, Ontario, a distance of 4 miles and 40.46 chains more or less to the high water mark of Lake Superior;

THENCE in a general North-westerly, Southerly, North-westerly, North-easterly, Northerly and North-westerly direction following the high water mark of Lake Superior to the intersection with a line drawn South astronomically from Mile Post 867 on the Canadian Pacific Railway mentioned aforesaid;

THENCE North astronomically along the said line to the point of commencement.

(4) THAT in addition to carrying out the other requirements of Section 6 of "The Municipal Corporations Quieting Orders Act", the Applicant shall within sixty days of the date hereof, cause a notice to be published in a newspaper having a general circulation in the Township of Schreiber, stating that an Order under "The Municipal Corporations Quieting Orders Act" (R.S.O. 1950, Chapter 245), as amended by "The Municipal Corporations Quieting Orders Amendment Act, 1954" has been issued by this Board, fixing the date of incorporation of the Township of Schreiber as the 1st day of January, A. D., 1901, and defining its area and boundaries, and that copies of such Order may be inspected at the Office of the Township Clerk.
